Upcoming Meetings for the Working Group and the Technical Advisory Committee

The first meetings of the Technical Advisory Committee and the Working Group have been scheduled.

The **Working Group will meet Tuesday, December 11 from 5PM to 7PM** in the first floor conference room of the CIRI Building at 2525 C Street, Anchorage AK 99503.

The **Technical Advisory Committee will meet on Wednesday, December 12 from 1:30PM to 3:30PM** at the Anchorage Airport Badge Office, located in Room NA165 of the North Terminal, 4600 Postmark Drive, Anchorage AK 99503. Parking is available at the North Terminal, and tickets can be validated at the Badge Office.

The public is invited to observe these meetings, and if time allows, provide comments at the end of the meetings.

What are the Working Group and the Technical Advisory Committee?

The Anchorage International Airport established the Working Group and the Technical Advisory Committee recognizing that many organizations have a vested interest in the Master Plan Update, and would like to be engaged more actively in the planning process. The Technical Advisory Committee and Working Group are two of many tools that will be used to gather public input throughout the Master Plan Update. While recommendations from the Technical Advisory Committee and Working Group will be considered by the Master Plan Update planning team, the Airport is responsible for development decisions.

The Working Group is a representative body of neighborhood, community, recreational, environmental, and business interest groups. The Technical Advisory Committee is comprised of aviation industry professionals charged with providing guidance on technical aspects of the Airport's Master Plan Update.

Potential members, representing a broad cross section of the community and

aviation industry, were invited to apply to become members of the Working Group and the Technical Advisory Committee. Participants were selected based on their area of interest, expertise, ability to participate, and commitment to providing input that reflects both their or their organization's views and the interests of the community. Where possible, the influence of public opinion will be documented.

It is the policy of the Department of Transportation and Public Facilities (DOT&PF) that no person shall be excluded from participation in, or be denied benefits of any and all programs or activities we provide based on race, religion, gender, age, marital status, ability, or national origin, regardless of the funding source including Federal Transit Administration, Federal Aviation Administration, Federal Highway Administration and State of Alaska Funds.
